Introduction:

This handbook is based on available public health information at the time of its creation. These plans were created with committees that had representation from school administrators, teachers, nurses, counselors, nutrition, maintenance and transportation directors along with AEA9 Consultants of the Durant CSD. The handbook will be adjusted based on newly available data and guidance from public health officials.

Mission Statement:

It is the mission of the Durant Community School District to enable students to understand the world around them and grow the talents within them so they can become fulfilled individuals and active, compassionate citizens.

Learning Options for Durant CSD

- 1. **On-Site** 100% of students physically in the building. Students will follow a traditional schedule with traditional classroom structure.
- Remote Instruction- By choosing not to send your student to school onsite, your student will be participating in the required online learning model provided by the district. At this point the district will be contracting EdGenuity, an online education provider approved by the State of Iowa. The provider will give us access to curriculum in all content areas K-12.

A student's educational success is our top priority. If a student is not earning passing grades, we as a district have an obligation to meet with the student/family and develop an alternate plan.

All Grades K-12th

A family that may need to use Edgenuity at the K-12 level would require a medical excuse. Any changes to the educational setting (online vs. in-person) will occur at semester only.

Any other circumstances will be evaluated by administration.

Health & Safety:

Our commitment to health and safety:

- 1. Hand sanitizer is available throughout the building
- 2. Transportation Cleaning- Sprayer
- 3. The Durant Maintenance Team moves throughout our facilities to clean on a regular basis.
- 4. The school nurse will monitor for communicable diseases and proceed as neccessary.

Students who become ill:

- Students or staff with fever of **100.0** or any other signs and symptoms of illness will be asked to go home. Please be prepared in some cases for your student to be excluded from school until they are symptom free or for a minimum of 24 hours.
- If you are called to pick up your student due to illness, it will be expected that he or she be picked up **AS SOON AS POSSIBLE**, or within a maximum **45-60 minutes**. Please make arrangements for this to happen. School staff MUST be able to reach a parent or another family contact when needed, and they must be picked up in a timely manner.

Cafeteria:

- 1. Regular lunch trays and disposable forks will be used. Food may be self-serve on a buffet or individually packaged.
- 2. Hand washing and glove use as normal following CDC and ServSafe Food Safety guidelines.
- 3. Cleaning/sanitizing procedures will take place in eating areas.
- 4. Hand sanitizer stations are available throughout lunch lines.

Buses:

- 1. Food or drinks will not be allowed on the buses.
- 2. Face masks are optional on the buses.

Building and Grounds Recommendations:

 Custodial staff members will assess the most effective manner for cleaning, sanitizing, and disinfecting buildings and grounds. Custodial schedules will be changed accordingly. United States Environmental Protection Agency (EPA) approved disinfectants for SARS-COV 2 will be used. In addition to the regularly scheduled cleaning, sanitizing, and disinfecting of all buildings, high-touch surfaces will be cleaned and disinfected daily including tables, doorknobs, light switches, countertops, handles, desks, phones, keyboards, toilets, faucets, and sinks.

Classrooms:

- 1. Interior doors will be kept open as much as possible
- 2. Tables will be spread far apart, utilizing all parts of the room for social distancing

Visitors in the building:

• Visitors will be limited to essential purposes during the school day to preserve the safest possible learning environment for students and staff. Therefore, visitors need to be pre-approved by the Pk-12 office first.

Procedure for picking up my child during the school day:

 If a student needs to leave school during the day for any reason, families will remain outside in their vehicle and phone the office. Students will be escorted out of the building.

Support appropriate general mitigation strategies across delivery models:

- The Durant Community School District did require staff to participate in IDOE recommended health training modules and will post and review district health expectations for staff/students and visitors.
- The Durant Community School District will follow IDOE/legal council recommendations regarding privacy in communication to others in suspected COVID 19 cases.
- The Durant Community School District encourages students and staff that are considered "high risk" or immunocompromised to visit their healthcare provider.

Social Emotional Behavior Health:

Who to contact, If my student is showing signs of emotional distress:

We encourage you to reach out to your student's teacher. You may also contact your building principal or guidance counselor for additional support.

Signs of emotional distress:

According to the American Psychological Association, symptoms of distress may look different in children and teens than adults. For children distress may look like:

- acting irritable or moody
- withdrawing from activities that used to give them pleasure
- routinely expressing worries
- complaining more than usual about school
- crying
- displaying surprising fearful reactions
- clinging to a parent or teacher
- sleeping too much or too little
- eating too much or too little

For teens distress may look like, all of the above signs of distress in children as well as:

- significantly avoiding parents
- abandoning long-time friendships for a new set of peers
- expressing excessive hostility toward family members
