Motion to approve the agenda as presented with the addition of new hire Richard Creamer, Transportation Director, was made by Ms. Oberlander, seconded by Ms. Whitlock and carried 5-0.

Motion to approve the minutes from the March 14, 2022 Regular Meeting was made by Ms. Lindsay, seconded by Ms. Oberlander and carried 5-0.

Tom Wuestenberg informed the board on a meeting he had with the City of Durant leaders regarding the possibility of improvements to the alley south of the elementary wing and the house removal at 510 7<sup>th</sup> St and converting that space into parking. Mr. Wuestenberg informed the board that the city employees were easy to talk to and eager to help and provided areal pictures of the area.
