DURANT COMMUNITY SCHOOL REGULAR BOARD MEETING OCTOBER 9, 2023 Unofficial Minutes

President Julie Rivera brought the meeting to order at 5:30 pm with the reading of the district mission statement and roll call. Present for roll: Katy Oberlander, Tara Lindsay, Travis Bullard, Carla Whitlock and Julie Rivera.
